## The objectives of this Company comprise 31 Items as follows:

- (1) To purchase, procure, hire, hire-purchase, holding ownership, possess, improve, use and manage of properties by other means as well as the interests of such properties, thereon.
- (2) To sell, transfer, mortgage, pledge, exchange and dispose of properties by all other means.
- (3) To act as broker, agent, commission agency for all enterprises and businesses except for the insurance industries, seeking the members for association and properties trading
- (4) To borrow from, overdraw on accounts with banks, juristic person, or other financial institutions; and to lend or give credit by other mean, with or without collateral securities, as well as to accept, issue, make a transfer and endorse bills of exchange or other negotiable instruments except those in banking business, finance, and credit foncier;
  - (5) To set branch offices or appoint the representatives inside and outside the country.
- (6) To become partner with limited liability in limited partnerships and to hold shares in limited companies and limited public companies.
- (7) To contract for construction of the building, commercial building, residential building, office building, road, bridge, tunnel and all other types of the construction work and civil works of all types.
- (8) To engage in multi-mode transport business, transport of goods and passengers by land, water and air in the country and abroad, as well as to engage in the service of clearing of goods from ports in accordance with customs formalities and booking of space for freight of every kind;
- (9) To engage in the service of collection, compilation, preparation, printing and publication of statistics and data on agriculture, industry, commerce, finance and marketing as well as analysis and evaluation of business operation;
- (10) To render service in the legal field, in accounting, engineering, architecture and advertising business;

- (11) To provide surety for debts, liability and performance of contracts by other individuals, and to furnish surety for persons who enter or depart the country in accordance with the immigration law, tax and duty law and other laws;
- (12) To act as advisor and give advice on administrative problems in the commercial and industrial fields as well as on production, marketing and distribution problems;
- (13) To operate service business of administration and trusteeship for any individual or organization and to act as the dealer and broker and to operate business of all kinds, (except for the insurance, membership and securities trade)
- (14) To engage in repair, maintenance, inspection, greasing and lubrication of vehicles of every kind and spraying of rust-proof solutions on such vehicles, as well as to carry out installation, inspection and repair of equipment for protection against danger of every kind;
  - (15) To hold academic trainings and seminars of all kinds indoors and outdoors.
  - (16) To issue shares in higher price than the nominal value.
- (17) To be hired for production according to objectives to persons, groups of persons, juristic persons, government units and organizations.
- (18) To operate business of transportation of products and supplies, distribution, multi-mode transportation and domestic and international transportation.
  - (19) To do any act regarding he customs procedure, import, export, transportation.
- (20) To operate business of information technology service, logistic system, transportation and distribution of products.
- (21) To operate manufacturing business of utensils, items and other appliances relating to transportation of all kinds.
  - (22) To be hired for packaging of parcels, products, supplies, items and goods of all kinds.
- (23) To tender for sale of goods based on the objectives to the individual, individual group, governmental authorities and organizations both domestically and internationally.
  - (24) To import for domestic sale and export for sale abroad of products based on the objectives.

- (25) To register, obtain permission, buy, rent, do advertising or procure otherwise the copyright, patent, trademark, certification mark, service mark, concession, patent, license or any other title for benefits of the company.
  - (26) To operate warehouse, airport, transportation facility and factory.
  - (27) To operate business of tourist guide as well as the tourism-relating business of all kinds.
- (28) To engage in the operation of private hospitals, and clinic and treatment of patients and sick persons and to undertake technical training and instruction in the medical and health fields;
- (29) To operate business of film production and distribution, cinema and other theater, resort, stadium, swimming pool and bowling parlor.
- (30) To operate business of transportation service of chemical and hazardous products of all kinds.
- (31) The company could issue any securities according to the law of securities and securities exchange for sale offer to the shareholders, any person or public
